- (A) The applicant shall notify the Enforcement Officer of any changes in the information contained in the application during the period for which the permit is in effect. A permit will be issued when the application has been determined to be complete and when the proposed work is determined to conform to the requirements of the Uniform Code. The authority conferred by such permit may be limited by conditions, if any, contained therein.
- (B) A building permit shall be prominently displayed on the property to which it pertains.
- (C) A building permit may be suspended or revoked if it is determined that the work to which it pertains is not proceeding in conformance with the Uniform Code or with any condition attached to the permit, or if there has been a misrepresentation or falsification of information in connection with the application for the permit.
- (D) A building permit issued pursuant to this Part shall expire one year from the date of issuance or upon the issuance of a certificate of occupancy (not a temporary certificate of occupancy), whichever occurs first. The permit may, upon written request, be renewed for successive one-year periods provided that (1) the permit has not been revoked or suspended at the time the application for renewal is made, (2) the relevant information in the application is up to date, and (3) the renewal fee is paid.
